 over and above what we had subscribed on that Day and  
 Instrument the Sums now aforesaid to our Names on the  
 Instrument and to be paid and performed at the same  
 time and Manner Mentioned in the Subscription aforesaid  
 Witness our hands this sixteenth Day of January - 1759 -
